NOTICE OF PUBLIC FOOTPATH DIVERSION ORDER

TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257 AND PARAGRAPH 1 OF SCHEDULE 14

PUBLIC FOOTPATH GF8 HANWOOD PARK KETTERING 2021

North Northamptonshire Council gives notice that on the 22nd April 2021 it made an Order under section 257 of the TCPA 1990 because it is satisfied that it is necessary to divert the footpath to which the Order relates to enable the development described in the Order to be carried out in accordance with the planning permission granted under Part III of the TCPA 1990 by Kettering Borough Council on 22 November 2018 under reference KET/2015/0967 and KET/2020/0239 (submitted 31st March 2020).

IF THIS ORDER IS CONFIRMED:

1. The footpath being GF8 at Hanwood Park Kettering shown by a broken red line on the Order plan (Plan), running from point A (NGR SP 9003, 7728) in a south easterly direction to point B (NGR SP 9005, 7725) where it turns to run in a more south easterly direction to point C (NGR SP 9011, 7723) where it turns and proceeds in a north easterly direction to point D (NGR SP 9019, 7729). It then runs in a more easterly direction to point E (NGR SP 9025, 7731) where it continues in a north easterly direction, terminating at point F (NGR SP 9048, 7740); shall be diverted from point F (NGR SP 9048, 7740) on the Order map in a south westerly direction to point E on the Order map (NGR SP 9025, 7731) where it turns to run in a more easterly direction to point D on the Plan (NGR SP 9019, 7729) where it bends to run in a northerly direction to point H on the Plan (NGR SP 9005, 7729). It then turns sharply to run in a westerly direction terminating at point A (NGR SP 9003, 7728). The alternative path is shown by a solid green line on the Plan. A boardwalk will be erected over the watercourse at point X on the Plan. The alternative path and boardwalk will be created to the reasonable satisfaction of the Council.
2. A copy of the Order and Plan (reference GF8 Hanwood Park 2021) may be inspected free of charge at the Council offices at Municipal Building, Bowling Green Road Kettering NN15 7QX between the hours of 9am and 5pm Monday to Fridays (excluding bank holidays and public holidays) from 20th May 2021 to 18th June 2021. 3. Any representations about or objections to the Order may be sent or delivered in writing to Sarah Coles at the address in Article 2 of this notice no later than 4pm on the 18th June 2021 being 28 days following the date of this notice.

4. If no representations or objections are made, or if made are withdrawn, the Council may confirm the Order as an unopposed order. If the Order is sent to the Secretary of State for confirmation any representations or objections which have not been withdrawn will be sent with the Order.
