### **Bedroom Rate Restriction**

- Introduced in April 2013
- 14% deduction from Housing Benefit where a tenant is under-occupying by one bedroom
- 25% deduction from Housing Benefit where a tenant is under-occupying by more than one bedroom



### **Bedroom Rate Restriction**

- Nationally, 10% of council tenants were affected by the bedroom rate restriction when it was introduced in April (Kettering 9.78%)
- The number of council tenants in arrears rose by 21% between March and June 2013 (Kettering +15%)
- The level of rent arrears increased by 16% between March and June 2013 (Kettering +19%)

## Rent Arrears in Kettering

- Rent arrears are £299,483; £62,682 above target
- 1,531 tenants (41.8%) are in arrears compared to 1,396 in this week in 2012/13
- 135 tenants owe more than £500 compared to 65 in this week in 2012/13
- In-depth analysis of rent arrears cases over £500 shows that there are 34 cases at £1000+ totalling £46,874.35 and of these 28 cases have an existing court or possession order against them



## Bedroom Rate Restriction in Kettering

- 305 council tenants (8.34%) are affected by the bedroom rate restriction
- 102 (33.5%) have clear rent accounts
- 203 (66.5%) have rent arrears of which 114 have rent arrears which appear to relate solely to the bedroom rate restriction
- Only four tenants affected by the Benefits Cap



# **Action to Support Tenants**

- Robust systems for monitoring rent arrears and taking action
  - Housing Income team at full strength
  - Tenants contacted immediately when payments are missed
  - 18 evictions since April with 2 more likely before Christmas
  - 6 further applications to Court
- Welfare reform information pack sent to all tenants
- Supplement on welfare reform in 'Connect'
- Open days for tenants and advice workers



### Action to Support Tenants

- One-to-one interviews with tenants affected by the bedroom rate restriction
  - 286 interviews completed with another 50 to do
- HomeMove
  - 9 tenants have been helped to downsize through a mutual exchange since April
- Mutual Exchanges
  - 26 tenants have moved through a mutual exchange since April



# **Action to Support Tenants**

- Discretionary Housing Payments
  - Paid to 55 tenants (15% of all tenants affected by the bedroom rate restriction)
  - Writing to all tenants affected by the bedroom rate restriction
- Tenancy support
  - Tenancy Support Worker
  - LifePlan Advisor
  - Working closely with the CAB and Community Law



### Issues

- It's still early days what will be the impact of winter fuel bills / Christmas / competing debts on the level of rent arrears?
- How can we engage hard-to-reach tenants?
- Can we do more to increase the supply of smaller affordable homes and help more people downsize?
