Annex 1 - Mandatory conditions

if this premises licence authorises the sale by retail of alcohol only for consumption off the premises then the following mandatory conditions apply:-

- 1. No supply of alcohol may be made under the premises licence at times when there is no designated premises supervisor in respect of the premises licence or at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence
- 3. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- 4. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

If this premises licence authorises the exhibition of films:-

5. Admission of children must be restricted in accordance with any recommendation made by the British Board of Film Classification.

If this premises licence details the use of door supervisors:-

6. All persons employed as door supervisors must be licensed by the Security Industry Authority.

Annex 2 - Conditions consistent with the operating schedule

Embedded Conditions Apply (The licence is granted on the condition that the restrictions contained within the enactments specified under Licensing Act 2003 Schedule 8 (6) are adhered to).

Generally the business is a service which I want to provide for the public. I will assist in making the community a safer and better place

Carry on and abide by our no sale to under 21's

By increasing security levels within the property & if necessary request an ASBO to reduce large numbers of people congregating outside the premises. I also currently liaise with Central club security for extra security & protection.

Carry on and record CCTV of the premises internally and externally. Keep all CCTV footage for 31 days and make readily available to Police.

I liaise with the night time enforcement officer - Paul Baker - to keep me up to date with ongoing issues.

CCTV of premises internally + CCTV of area outside premises
Part of Kettering crime prevention, Radio Link Newland Centre security, use of town
CCTV system

As above and also keep using the town centre radio network linked to CCTV control room (Newlands Centre).

Public liability/employee liability insurance.

As previously mentioned I will take all the above precautions to reduce public nuisance as well as my own initiative, i.e if members of public are drunk I will refuse sale of alcohol

By not selling alcohol to persons over the age of 18 who may supply to minors.

Children should not be in the streets at that time of night, however, if they are I will do whatever I can to help.

To liaise with CSO Officers and education authorities from the nearby William Knibb Centre.

Alcohol will not be sold to any person under the age of 18.

Think 21 scheme will be operated. If a person seeking alcohol looks under 21 then they will be asked to produce PASS accredited proof of their age. If this cannot be produced the sale will be refused and a record made in a refusals register.

Regular staff training will be carried out to ensure staff are aware of the legislation covering age restricted sales.

Relevant posters provided by the Trading Standards Service will be displayed in the premises.

Display posters in premises regarding age limit of 21 for alcohol sales

CCTV equipment shall operate within the premises and recordings shall be retained for a minimum of 31 days. A copy of any recordings will be provided to the Police upon request.

The operator shall ensure that the sale or supply of alcohol to any person appearing to be under the age of 18 years will only be made when appropriate proof has been given to verify the age of the purchaser. Suitable Challenge 21 literature shall be displayed within the store.

The operator shall ensure that a refusals register is maintained and kept on the premises in relation to age restricted goods. This should be made available for inspection by the Police/Trading Standards when required.

The operators shall ensure that in order to secure the promotion of the licensing objectives, and for the safety of the stores employees, between the opening hours of 7pm and 7am on any day of the week, a minimum of two members of staff shall be working on the premises. If at any time during this period the staffing level cannot be fulfilled the store entrance should be secured and all sales made via the serving hatch kiosk.

Annex 3 - Conditions attached after a hearing by the licensing authority

1. That the Designated Premises Supervisor Nirmala Rani Paul be removed

2. That the following additional conditions be placed on the Premises Licence: a) The Designated Premises Supervisor shall possess a 'National Certificate

for Designated Premises Supervisors' or equivalent nationally recognised qualification approved by the licensing authority and the Police prior to appointment.

b) A personal licence holder shall be on duty at all times alcohol is for sale

during trading hours.

c) All staff shall be trained in relation to the sale of alcohol to drunks and underage persons and details of this training and training records are to be maintained and produced immediately to the licensing authority or Police upon request.
