Annex 1 - Mandatory Conditions

If this premises licence authorises the sale by retail or supply of alcohol to members or guests:-

- 1. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relations to the premises.
- 2. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
 - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol) or
 - ii. drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
 - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on
 - i. the outcome of a race, competition or other event or process, or
 - ii. the likelihood of anything occurring or not occurring:
 - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 3. The responsible person shall ensure no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 4. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

- 5. No supply of alcohol may be made under the premises licence at times when there is no designated premises supervisor in respect of the premises licence or at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- 6. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence
- 7. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- 8. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 9. The responsible person shall ensure that -
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
 - (i) beer or cider: ½ pint
 - (ii) gin, rum, vodka or whisky:25ml or 35ml; and
 - (iii) still wine in a glass:125ml; and
 - (b) customers are made aware of the availability of these measures.

If this premises licence authorises the exhibition of films:-

10. Admission of children must be restricted in accordance with any recommendation made by the British Board of Film Classification.

If this premises licence details the use of door supervisors:-

11. All persons employed as door supervisors must be licensed by the Security Industry Authority.

Annex 2 — Conditions consistent with the operating schedule

Embedded Conditions Apply (The licence is granted on the condition that the restrictions contained within the enactments specified under Licensing Act 2003 Schedule 8 (6) are adhered to).

Good management during extended hours and licensable activities ensuring compliance with the Licensing Act as at present.

Liaison with local police and licensing authority and working with local drug squad.

Provision of public safety by effective management. Provision of sufficient first aid boxes and accident reporting procedures.

Customers requested to leave premises in orderly manner.

Children under 16 to be accompanied by an adult. No alcohol sales to a person under 18 yrs.

Annex 3 Conditions attached after a hearing by the licensing authority

- 1. All external doors, other that those used for emergency exits only, shall be provided with lobbies, the doors to which shall be fitted with automatic closing devices. The doors shall be kept closed, so far as is practicable, at any time when regulated entertainment is taking place, or facilities are being provided for regulated entertainment.
- 2. All external windows shall be kept closed at any time when regulated entertainment is taking place, or facilities are being provided for regulated entertainment. Ventilation shall only be provided by suitable and sufficient mechanical means (the amount of ventilation provided is also a requirement under Health and safety legislation). The mechanical system shall be operated as required and maintained thereafter.
- 3. All Emergency exit shall be fitted with well sealed acoustic doors.
- 4. The Licensee(s) must at all times ensure, as far **a**s is practicable, that people on, or leaving, the licensed premises conduct themselves in an orderly manners, and do not cause annoyance to the neighbourhood.
- 5. Regulated entertainment, in the form of the performance of live music or the playing or recorded music, shall only take place indoors between the hours of 11:00 hours and 23:00 hours Monday to Saturday, and 12:00 hours to 22:30 hours on Sundays. Standard hours will be extended to 00:00 midnight on the Saturday, Sunday and Monday of Bank Holiday Weekends, 24th December, 26th December, 27th December, 1st January and 2nd January; and extended to 11:00 hours the following morning on 31st December.
- 6. Regulated entertainment, in the form of the performance of live music shall only consist of amplified and non-amplified music with a maximum of two performers. Karaoke is considered to fall outside the **res**triction of this condition and is not permitted.
