Licensing Act 2003 New Grant Application - Representations Othman Kadir Hassan, 6-10 Montagu Street, Kettering, NN16 8XG Mr Farman Omar Mustafah

Responsible Authority Representation

Northamptonshire County Council Trading Standards Service is a Responsible Authority for the purposes of the above Act. I wish to lodge a representation against above applicant in their application for a new licence.

The representation relates to the following licensing objectives; The prevention of crime and disorder The protection of children from harm

Mr Farman Omar Mustafah has been specified on the application as the designated premises supervisor for the above premises.

Although Mr Mustafah had given this Service a different home address which is based in Northamptonshire, Thrapston Licensing unit have be able to confirm the following; Farman Omar Mustafah is the licence holder for Euro Express 10 New Post Office Square Corby and the Peterborough home address and personal licence number is the same as that quoted on this new application.

- Section 4(2)(a) The prevention of crime and disorder

Mr Farman Omar Mustafah was the owner of International Supermarket, 194 – 196 Wellingborough Road, Northampton, NN1 4EB in 2014. In June 2014 an undercover test purchase of a pack of cigarettes was made. On the 13th July 2014 International

Supermarket was subject to an inspection by this Service during which a significant quantity of illicit cigarettes and a quantity of tobacco were found and seized. The items seized consisted of 1108 packets of illicit cigarettes and 15 pouches of illicit tobacco. Mr Mustafah was present at the premises at the time of the search and seizure. Mr Mustafah signed a traders notice as acknowledgment of the seizure.

Following intelligence received from Corby Borough Council in July 2014 an undercover test purchase of a pack of cigarettes was made at Euro Express, 10 New Post Office Square, Corby. On the 25th July 2014 Euro Express was subject to an inspection by this Service during which 2 packets of illicit cigarettes were found and seized. Mr Farman Omar Mustafah was identified as the owner of the business.

On the 22nd August 2014 as owner of the business Mr Farman Omar Mustafah signed a formal Enterprise Act 2002 Undertaking regarding the possession and supply of tobacco products contrary to The Tobacco Products (Manufacture, Presentation, and Sale) (Safety) Regulations 2002.

On the 12th March 2015 this Service sent a caution letter to Mr Farman Omar Mustafah regarding the seizures that had taken place at his premises. A further copy of the letter was sent on 2nd April 2015. No acknowledgement was returned.

On the 16th July 2015 Euro Express, 10 New Post Office Square, Corby was subject to an inspection by this Service during which 154 packets of illicit cigarettes and 11 pouches of illicit tobacco were found and seized. Mr Farman Omar Mustafah was identified as the owner of the business and has been confirmed as the lease holder on a land registry search.

The nature of these incidents indicates that Mr Farman Omar Mustafah as owner of the above businesses disregarded the legal requirements in selling tobacco products contrary to the licensing objective of prevention of crime and disorder and we object to the appointment of such a person as a Designated Premises Supervisor at 6-10 Montagu Street Kettering. It is therefore our representation that this Authority has concerns that the licensing objective of the prevention of crime and disorder will not be met at these premises with Mr Mustafah being the Designated Premises Supervisor.

- Section 4(2)(d) The protection of children from harm

With regard to the above licensing objective we consider the detail in the application insufficient and would expect reference to be made to the following matters:

- Asking for proof of age and valid types of proof of age cards (PASS Cards)
- Staff training and keeping a record of the training
- Use of refusals register
- Display of relevant posters
- Till prompts where appropriate

In making this representation I refer you to Official Guidance:

In the Amended Guidance Issued Under Section 182 Of The Licensing Act 2003 issued by the Home Secretary it states:

11.26 There is certain criminal activity that may arise in connection with licensed premises, which the Secretary of State considers should be treated particularly seriously. These are the use of the licensed premises:

• [...]

• for the purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people;

• [...] and

• for the sale of smuggled tobacco and alcohol.

11.27 It is envisaged that licensing authorities, the police and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be **ser**iously considered.

Contravening the Tobacco Products (Manufacture, Presentation and Sale) (Safety) **Regulations 2002**

• By supplying, including offering, exposing or possessing for supply, non-compliant tobacco products contrary to Regulation 14; specifically where the producer has failed to mark the product with the statutory warnings in the prescribed format, in English.

Contravening the Trade Marks Act 1994

By selling, exposing for sale or having in possession, custody or control in the course of a business goods which bear a sign identical to, or likely to be mistaken for, a registered trade mark with a view to gain for myself or another and without the consent of the trade mark holder, contrary to section 92 of the Act.

IF YOU SIGN THIS DOCUMENT YOU AGREE TO OBEY ITS REQUIREMENTS. AN ENFORCEMENT ORDER MAY BE SOUGHT FROM THE COURT IF YOU CONTINUE TO BREACH OR CONTRAVENE THE LEGISLATION SET OUT ABOVE.

We do regularly monitor the sales of illicit products around the County and work closely with our partner agencies to ensure that illegal sales are dealt with appropriately.

I have considered the facts of this matter and I propose to deal with it by way of a formal undertaking under the Enterprise Act 2002.

Therefore I request you sign a formal undertaking that you will desist from conducting any business that you are involved with in the future in a manner that infringes any UK and European consumer protection legislation covered by the Enterprise Act 2002. The undertaking is being hand delivered to you, with a voluntary surrender form. If you accept this method of dealing with these offences, please sign both the undertaking and the voluntary surrender and return to me by Wednesday 27th August 2014.

I am obliged to inform you that should you fail to accept the undertaking, there is provision within the Enterprise Act 2002 for this Authority to seek an enforcement order through the High Court or the County Court which, if granted, will compel you to conduct your business in a manner that does not infringe abovementioned UK and European consumer protection legislation.
