Title	NORTH NORTHAMPTONSHIRE JOINT CORE STRATEGY (PART 1 LOCAL PLAN) AND SITE SPECIFIC PART 2 LOCAL PLAN PROGRAMME		

# 1. PURPOSE OF REPORT

To formally update Members on the adoption of the North Northamptonshire Joint Core Strategy and to agree the programme for progressing the Site Specific Part 2 Local Plan; and

To Inform Members on the proposed approach to developing the Spatial Portrait, Vision and Outcomes for the Site Specific Part 2 Local Plan.

## 2. INFORMATION

## North Northamptonshire Joint Core Strategy

- 2.1 Members will recall that at the last meeting of this Committee on 21<sup>st</sup> July 2016, a verbal update was provided to announce that the North Northamptonshire Joint Core Strategy (JCS) had been adopted (Minute 16.PP.12 refers). The JCS was subsequently subject to a six-week period to allow for any High Court challenge. That period has since passed with no legal challenge made.
- 2.2 The JCS is one part of the statutory Development Plan for North Northamptonshire. The Development Plan, as it relates to Kettering Borough, consists of the JCS (Part 1 Local Plan); saved policies of the Kettering Local Plan (1995); and the Kettering Town Centre Area Action Plan (adopted July 2011). To ensure there are planning policies providing borough-wide coverage for development, officers will be advancing the Site Specific Part 2 Local Plan. This document will also replace the remaining policies of the 1995 Local Plan.
- 2.3 One consequence of the new JCS being adopted is that a number of these extant local plan policies 7 in total, which are now deleted as they are covered by more up-to-date JCS policies. (For example, policies relating to affordable housing.) For information, a copy of the remaining saved policies from the Local Plan in list form is attached in Appendix 1.
- 2.4 Following completion of the Site Specific Part 2 Local Plan, the Development Plan for the Kettering Borough area will comprise: the North Northamptonshire Joint Core Strategy – Part 1 Local Plan; Kettering Borough Site Specific Part 2

Local Plan; Kettering Town Centre Area Action Plan (2011); as well as any 'made' (adopted) Neighbourhood Plans.

### Site Specific Part 2 Local Plan

- 2.5 Members may recall that the Joint Core Strategy (JCS) is focussed on a set of strategic planning policies, and the Site Specific Part 2 Local Plan (SSP2) will cover the whole of the Borough. It will include the identification of sites for housing, employment, gypsy and traveller accommodation, recreation and other land uses.
- 2.6 Members may also recall that on 2<sup>nd</sup> September 2015, a report was presented to, and agreed by Members updating on the progress and programme for completing the Part 2 Local Plan (Minute 16.PP.09). There has been slippage in the programme, in part due to a delay in adopting the JCS following Examination in November 2015, but also to take account of the need for additional evidence gathering in some areas of the Plan. Particular areas requiring additional resource include Open Space and Recreation provision, Green Infrastructure Strategy, and Employment Land Allocations.
- 2.7 The revised programme for progressing the Part 2 Local Plan is therefore proposed as follow:
  - Draft Plan for consultation March 2017
  - Pre-Submission Plan for consultation July 2017
  - Submission to Secretary of State September 2017
  - Examination December 2017
  - Receipt of Inspector's Report May 2018
  - Adoption July 2018

#### **Spatial Portrait, Vision and Outcomes**

- 2.8 The Spatial Portrait, Vision and Outcomes for the Part 2 Local Plan will be an opening introductory chapter to the Plan, setting the spatial context for Kettering Borough as an administrative area, and its characteristics and position within the surrounding area. It will describe the relationship between the Part 1 and Part 2 Local Plan, seeking to tie the two together into a cohesive, strong set of policies to take growth forward to 2031.
- 2.9 Taking the agreed JCS vision as a starting point the SSP2 vision will be locally distinctive to Kettering Borough, and will set out how this plan will deliver the wider North Northamptonshire vision within its own context. It will draw upon relevant Kettering Borough Council corporate strategies and plans, including the Sustainable Community Strategy. An initial draft copy of the Spatial Portrait, Vision and Outcomes is provided at Appendix 2.

- 2) Agree the timescales for the preparation of the Site Specific Proposals Local Development Document at paragraphs 2.5 to 2.7; and
- 3) Note and agree to the proposed approach to work on the draft Spatial Portrait, Vision and Objectives for the Site Specific Part 2 Local Plan at paragraph 2.8 to 2.9.
