## SECRETARY OF STATE BACKS LARGE SCALE HOUSING GROWTH

Today the Rt Hon Sajid Javid MP, Secretary of State for Communities and Local Government showed his support for local councils driving the delivery of large scale development. Addressing a meeting of the TCPA New Communities Group, a group of local authorities and development corporations delivering large scale development, the Minister said housing was his "number one priority". Emphasising the opportunity presented by the forthcoming Housing White Paper, the Secretary of State set out some of the short term and long-term measures it might include:

"The White Paper, that I hope to bring out next month, will seek to make sure that we release land in the right places...and include measures to diversify the market – we don't have enough SME builders – and we must increase the different types of homes, including custom build."

## He added:

"[addressing the housing challenge] is only going to work if every government department works together...we need consensus in parliament as well...I want to work with the opposition on this. It's a big challenge and it's about time we did something much more radical in this space...I need the help of the New Communities Group, TCPA and other organisations to give your ideas and thoughts"

The Minister was addressing a parliamentary briefing for TCPA New Communities Group. Members are local authority planning departments and development corporations planning and delivering exemplary large-scale new communities, from Garden City inspired new towns and villages to urban regeneration and extension schemes. The Group encourages a sharing of knowledge and best practice, and together provides innovative local leadership for plans delivering in the region of 150,000 new homes. Today's briefing was held with support from Places for People, and demonstrated the progress made by a number of local authorities as they strive to create communities that meet the highest standards.

Hugh Ellis, TCPA Interim Chief Executive said:

"I am delighted Government recognises the important role of the TCPA New Communities

Group. Going forward it is critical that Government reinforces the need for quality and

inclusion, as well as housing numbers. The forthcoming Housing White Paper provides a

once in a generation opportunity to create the kind of places the nation so desperately

needs".

The briefing was hosted by Mark Pawsey MP for Rugby and Bulkington at Portcullis House.

Also speaking was Roberta Blackman-Woods MP, Shadow Minister for Local Government

and Housing, who said "Housing numbers are important but it's the type and quality of

development that matters. Good quality development can help to get buy in from local

people... the garden city principles provide a framework for this".

Louise Wyman, responsible for Garden Villages, Towns and Cities at Homes and

Communities Agency outlined the Government's plans for Garden Villages, and the Leaders

of the NCG councils shared their ambition and experience of delivering comprehensively

planned, sustainable growth at the local level, and highlighted the significant amount of

progress that continues to be made.
