1. PURPOSE OF REPORT

The report seeks the views of the Kettering Town Forum on the proposed amalgamation of the Kettering Town Centre Taskforce Group.

2. <u>INFORMATION</u>

- 2.1 The Kettering Town Centre Taskforce was set up many years ago, initially to improve the feel of the town centre at night, to reduce the fear and experience of crime and to apply best practice in relation to managing the evening economy. It involved elected members, officers, police, fire, pub and taxi trade representatives and has met regularly since that time, looking at a series of projects.
- 2.2. It last met on the 6th December and reviewed its Terms of Reference (Appendix 1). It was noted that the Town Centre Taskforce attendance has been deteriorating over the past two meeting resulting in a "disappointing attendance"; however Healthy High Streets, reductions in town centre violence, the setup of the street pastors scheme, the Purple Flag award and the Market Place Regeneration were noted as being key successes over the period the taskforce had been active.
- 2.3 The taskforce members felt that the purpose and much of the membership of the taskforce was duplicated alongside the Kettering Town Forum and that the focus and work of the taskforce should be fully transferred into the Town Forum. Retail sector representatives could be sought out to attend these meetings to encourage organisations to share their views, opinions and ideas.
- 2.4 As a result of this, the views of the Kettering Town Forum are sought before further action is taken towards strengthening the engagement, particularly with the Town Centre business community, which is currently re-energising its own collective efforts at the moment.
