17.A6TF.01 ELECTION OF CHAIR

17.A6TF.06 POLICE STATISTICS

Sergeant Scott Little attended the meeting to present the crime statistics for the A6 Towns over the last 24 months.

It was reported that crime was now recorded in individual wards. Theft was also recorded slightly differently.

In Barton Seagrave 13 fewer crimes had been recorded over the last 12 months. A number of robberies had been recorded, some of these committed by children of school age. One offender had been apprehended.

In Burton Latimer, criminal damage had increased, as had violence offences.

Desborough had recorded an increase of 88 offences, including drug offences and thefts from motor vehicles. Violence offences had also increased.

In Rothwell, drug-related and burglaries had increased.

A number of community protection notice warnings in relation to antisocial behaviour had been issued, in partnership with the Council. Hotspots included the Leisure Centre, the Grange estate and Dunkirk Avenue park in Desborough. In Rothwell the Skate Park was also considered to be a hotspot. Latimer Arts College was a hotspot in Barton Seagrave, but this was mainly linked to the robberies

previously mentioned committed by school age children. Pupils had been excluded from school as a result.

In Burton Latimer, speeding, parking, drugs and antisocial behaviour was a problem in some areas and were being targeted by the police. 96 warning letters and 13 speeding tickets had been issued.

The police had supported some local events recently, including the Local Elections, the General Election and the Women's Tour.

Discussion was held on decriminalised parking progress following a meeting between the Kettering Borough Council and Northamptonshire County Council in May 2016. It was noted that a further meeting was planned for 29th June and it was hoped that progress would be made following this meeting.

It was <u>AGREED</u> that Decriminalised Parking be placed on the agenda for the meeting on 13th September

In response to a question, it was noted that separate records of Domestic Violence incidents were not reported for the purposes of the Crime Statistics, although the police did hold separate records.

Sgt Little was thanked for his attendance.

17.A6TF.07 SUMMER EVENTS

A presentation was given by the Head of Corporate Development on the Borough's Summer Events for 2017. The presentation included feedback on the Women's Tour, which took place on 7th June.

Discussion was held on the use of Social Media to publicise events and town councillors were urged to contact the Council if they were aware of any events in the A6 towns which might be included on social media pages.

Town councillors were advised that the Borough Council could help with promotion of events in other ways, such as through advertisements. However, information on events was required several months in advance if inclusion in 'What's On' was to be requested.

Feedback from other Forums

Rural Forum

The last meeting had been held on 2nd February, with the next meeting due to take place on 29th June. The Rural Forum had invited the Chief Constable to attend a future meeting and this had been confirmed. The Forum was hopeful that both the MP and Police and Crime Commissioner would also confirm attendance at a future meeting.

The Forum was continuing to discuss street lighting in rural areas, the provision of Broadband and the subject of truck stops.
