On the 27th of March 2014 Northamptonshire County Council (NCC) Trading Standards Department (TSD) conducted a Test Purchase Operation at the store and illicit tobacco was purchased from the store.

Two packets of illicit Marlboro lights were sold at £5.00 each.

On the 12th of June 2014 TSD Officers conducted another Test Purchase Operation at the store and again illicit tobacco was purchased.

Two apckets of illicit L&M cigarettes at £4.50 each.

On the 11th of July 2014 TSD Officers visited the store and illicit tobacco was seized from behind the till and on a shelf behind the till, also from a concealed unit hinged under the counter.

Total 55 packets of illicit cigarettes, 9 pouches of illicit hand rolling tobacco and 72 packets of foreign labelled blunts.

On the 13th of August 2014 TSD Officers visited the store to serve an Enterprise Act undertaking on Mr AHMADI.

On the 6th of November 2014 TSD Officers visited the store and illicit tobacco was seized from underneath the counter also illicit tocbacco was discovered in the alleyway to the side of the store.

Total 275 packets of foreign labelled cigarettes and 6 pouches of hand rolling tobacco.

On the 12th of February 2015 Mr AHMADI entered into a formal undertaking under the terms of the Enterprise Act.

On the 2nd of September 2016 TSD Officers conducted a Tesp Purchase Operation at the store and illicit tobacco was sold.

One packet of Marlboro Gold cigarettes at £5.00.

On the 21st of December 2016 a Traders Notice was issued to Mr AHMADI by TSD Officers.

On the 20th of January 2017 a letter was issued to Mr AHMADI by TSD Officers informing that the store was being monitored by the department in respect of illicit tobacco sales, this was signed by Mr AHMADI.

On the 1st of February 2017 TSD Officers conducted a Test Purchase Operation at the store and illicit tobacco was sold, a packet of foreign labelled Marlboro Gold cigarettes.

On the 22nd of February 2017 TSD Officers visited the store and illicit tobacco was seized from within the store, 786 packets of cigarettes and 37 pouches of tobacco, 53 of these packets are counterfeit.

When making this application Northamptonshire Police have consulted the statutory section 182 Guidance that accompanies the Licensing Act 2003, specifically paragraphs 2.1 and 11.24 to 11.28 which relates to Reviews in connection with crime.

In addition the Licensing Committee must be satisfied that any measures that they deem fit are appropriate to address the licensing objective of the Prevention of Crime and Disorder. In this individual instance this centres directly on the management of

the premises. To modify the Premises Licence and/or remove the Designated Premises Supervisor in Northamptonshire Police's opinion would not curtail this criminal activity as detailed already in these Review papers. It is also contended that a restriction of the licensing hours would also not address the criminality. R (Bassetlaw District Council) v Worksop Magistrates Court outlines the case that the action(s) taken by the Licensing Committee can be punitive. Northamptonshire Police ask the Licensing Committee to consider Revocation of this particular Premises Licence in the interests of the wider community for reasons detailed in the above case. The wider community in this instance is the shop keeper selling tobacco legally and at a higher cost to their own business and those other businesses who are involved or considering engaging in this illegal activity. Contained with these papers are copies of the formal documents served on the Premises Licence Holder by NCC TSD.
