Title	DESIGNATION OF MONITORING OFFICER		

1. <u>PURPOSE OF REPORT</u>

To formally approve changes to the Statutory Officer and Proper Officer designations, to enable the Council to comply with legislative requirements.

2. INFORMATION

- 2.1 The Council has three key statutory officer posts for which Council must formally approve which officers are designated into which posts. The three posts are: -
 - Head of Paid Service
 - Statutory Finance Officer (s151)
 - Monitoring Officer
- 2.2. At its meeting in July 2017, the council confirmed permanent appointments to the first two posts and the temporary appointment of Martin Hammond as Monitoring officer until such time as the post of Head of Legal and Democratic Services was filled.
- 2.3 The Council must appoint a Monitoring Officer to ensure that it complies with statutory requirements. The Monitoring Officer is a statutory appointment pursuant to s5 of the Local Government & Housing Act 1989, and should be a senior member of staff.
- 2.4 Helen Edwards was appointed as the Head of Legal and Democratic Services and commenced work on the 19th February. It is proposed that she now be appointed as Monitoring Officer, with effect from 1st March 2018.
- 2.5. Helen Edwards will be responsible for appointing her own Deputy Monitoring Officer.
- 2.6. Historically, the Head of Legal and Democratic Services also had a number of proper officer functions (i.e. those delegated statutory powers held as the post holder), which were, in the short term, also re-allocated to other officers. It is proposed to re-unite these roles with the service head role, as follows:-
