Title	STRUCTURAL CHANGE ORDER		

1. PURPOSE OF REPORT

To appraise members of the likely inclusions within the Structural Change Order for Local Government in Northamptonshire and to determine Members preferences.

2. BACKGROUND

- 2.1 At the time of writing this report, the Secretary of State had not decided whether to accept the Joint Proposal submitted by 7 of the 8 Local authorities in Northamptonshire. However, he has decided to embark on an eight-week public consultation from 29th November 2018 to 25th January 2019.
- 2.2 Subject to his consideration of consultation responses, ultimately this could lead to a Parliamentary decision to establish a new unitary authority for a West and North Northamptonshire in Spring 2020, with a shadow unitary authority as the interim transition body from late Spring 2019.
- 2.3 An important element in this process of becoming a Unitary authority is the drafting and making of the Structural Change Order (SCO).
- 2.4 The SCO is made by the Secretary of State for Housing, Communities and Local Government in the exercise of his powers within the Local Government and Public Involvement in Health Act 2007.
- 2.5 There are two key reasons as to why it is important for this committee to consider the implications of the SCO at this stage in time.
- 2.6 Firstly, although the SCO is the ultimate decision of the Secretary of State (SOS) it is clear that there will be the opportunity for formal dialogue between representatives of the Local Authorities and the MCHLG prior to the drafting of the SCO post the closure of the consultation process. Therefore it will be important to be clear about the individual authorities and ultimately the North Northamptonshire preferences of its content.
- 2.7 Secondly, once the SCO is laid before parliament, the first meeting of the "Shadow Authority", must be held not later than 14 days after the coming into force of the order. Therefore, it will be important that all the background work
