Title	POLLING PLACE AND POLLING DISTRICT REVIEW		

1. PURPOSE OF REPORT

To seek the comments of the Rural Forum in relation to the polling place and polling district review and its impact on the Parishes in the Borough.

2. **INFORMATION**

- 2.1 The Electoral Registration and Administration Act 2013 amends the Representation of the People Act 1983 to make it a legal requirement that Returning Officers review the polling districts and polling places within their Council area every five years. The last review for Kettering Borough took place in 2014, and the findings were implemented at the Borough Council elections held in May 2015. They have been in place since then, subject to a small number of amendments when premises have become unavailable or unsuitable for use as polling stations or in response to local requests to move polling stations.
- 2.2 As detailed above the review of polling districts and places is a statutory requirement that must be undertaken and completed by January 2020 irrespective of any impending changes to the provision of local government services in Northamptonshire.
- 2.3 At Appendix A to this report, members of the Forum will find a copy of the Terms of Reference for the review.
- 2.4 At Appendix B to this report, members of the Forum will find a copy of the Acting Returning Officer's Report on existing Polling Places.

3. FUTURE PROVISION

3.1 Kettering Borough continues to grow in terms of the numbers of residential houses and electors. Over the next five-year period, it is estimated that there could be up to an additional 4,200 houses built within the Borough.

- 3.2 Although there are many external factors that can affect these figures coming to fruition, we must base our planning for the provision of facilities for voters and the structures for polling on the basis that these levels of development will take place. This will necessitate reviews of the structure of the Register of Electors in areas of high development, along with a review of the available facilities to ensure they are capable of dealing with increased numbers of voters, and the identification of new facilities where necessary. We must ensure that what is in place for the 2020 elections is also suitable for polls up to 2024. The structure of the Register of Electors will also need to reflect both existing levels of electors and accommodate the increases that will inevitably follow the development and occupation of new housing.
- 3.3 Below is an analysis of rural areas that highlights
 - the anticipated development and the potential increase in electorate
 - what is available currently in terms of premises used for polling and the impact on future usage of those buildings as a result of the increased numbers.
 - whether or not there is any planned developments of community facilities as a result of the increase in residential properties.
