I act on behalf of the Chief Officer of Police Mr Adderley, he has delegated responsibility and authorised me to act on his behalf with regard to representations made by Northamptonshire Police to Licensing Authoritles across the county of Northamptonshire.

I am objecting to the grant of the above Premises Licence application the Licensing Objectives of the Prevention of Crime and Disorder and the Protection of Children from Harm specifically.

The operating schedule is too vague to properly assess whether the Licensing Objectives will be promoted, I have E-mailed the applicant to offer a more defined a robust wording of the operating schedule in relation to CCTV and the prevention of underage sales on the 29/10/2019.

The applicant responded on the 30/10/2019 stating he would install CCTV and let Northamptonshire Police know when it was completed, this has raised concerns in respect of this application, primarily that what has been put forward on the operating schedule it would appear is not already in place. I have attempted to clarify with the applicant on the 30/10/2019 whether there is CCTV or not but have not had a response as of the 31/10/2019.
