Embedded condition under s77 Licensing Act 1964 relating to ancillary nature of provision of food removed.

- R No intoxicating licquor shall be supplied otherwise than to:
 - i) A member of the said club who has been a member for at least 2 days or whose nomination or application for membership was made at least 2 days before his admission.
 - ii) a quest of such member bona fide entertained by him at his own expense
 - iii) a person whose admission to the club premises is provided for by rules of the club.
- There shall be rules of the club for the election of members and a copy of such rules and any other rules shall be deposited with the Clerk to the Licensing Justices. Notice of any alteration to any of the rules shall be given to the Clerk within 14 days.
- A list of the names and addresses of all the members of the said club shall be kept on the premises and shall be produced for inspection on demand by a constable in uniform.

A constable in uniform shall be permitted to enter the premises at all reasonable times.

No application shall be made under the authority of the licence for the grant of an occasional licence.

No alterations governing the qualification for membership and the admission of members or guests shall be made without the consent of the Licensing justices.

The maximum number of persons permitted on the premises shall be in accordance with Fire Service recommendations.
