

Operating Schedule

General:

Active member of Pubwatch

Crime and Disorder:

All door supervisors to be S.I.A registered.

All door supervisors are trained and are empowered to deal with underage drinking. All door staff are SIA registered minimum SIA Guidelines for doormen per occupants is exceeded minimum 1 per 200 occupants.

Policy Statement in relation to underage access to premises no under 18 year olds permitted on the premises only recognized proof of age schemes will be accepted i.e. photographic Driving Licence, Passport, Portland Prove It Card or similar scheme.

Appropriate signage on all entrances with regard to checking ages.

Licence door supervisors will be deployed to escort patrons off the premises and clear the area.

Licence door supervisors advised of their responsibilities for prevention of disorder in the vicinity of the premises.

Appropriate signage to be displayed in relation to Drug Awareness and spiking of drinks with drugs.

Appropriate training for staff on drug awareness including spiking of drinks with drugs.

A policy will be adopted in relation to random searches by approved door supervisors to prevent the bringing of illegal drugs or weapons on to the premises.

CCTV is in place which is recordable and complies with minimum requirements by Northants Police Crime Prevention and Effective Management.

Membership to the Kettering Pub watch scheme.

Promotions to encourage sensible drinking including measures to encourage purchase of soft drinks to include the provision of tea, coffee and soft drinks for a period of 30 mins after alcohol sales cease.

Alcohol sales to cease 30 mins before the premises closes to the public to assist in a controlled dispersal of patrons and to assist policing in the local area and to prevent overcrowding outside the premises in relation to taxi services for patrols leaving the premises.

No admission to any patrons after 02:00am to discourage patrons from other establishments attending premises.

Public Safety:

Door supervisors to monitor numbers of persons entering to prevent overcrowding. Daily log to be maintained when supervisors on duty.

All door staff SIA registered.

Adequate and appropriate staffing levels.

No glasses or bottles to be taken outside the premises unless between the hours of 11:00 hours and 20:00 hours in the outside drinking area.

A Health & Safety Policy is in place to promote the highest and practicable standards of Health & Safety and welfare throughout the work place for areas used by employees, visits to the workplace and areas open to the general public.

Maximum number of persons permitted on the premises shall be in accordance with the Fire Officers Guidelines.

Protection of Children from Harm:

No conditions identified.

Public Nuisance:

No sales of alcohol to under 18 year olds. No under 18's after 19:00 hours on any day.

Appropriate notices on exits encouraging patrons to leave quietly.

Door supervisors to be deployed and responsibilities extending to encouragement of patrons to leave quietly.

Doors and windows to remain shut when regulated entertainment takes place except for entrance and egress.

Door supervisors should note and record all incidents in a daily log. That book should be available for inspection by any Police Officer or representative from the Borough Council.

No activity such as emptying glass bottles or handling barrels external to the fabric of the building between 21:00 and 09:00.

Mandatory Conditions

If this premises licence authorises the sale of alcohol:-

1. No supply of alcohol may be made under the premises licence at times when there is no designated premises supervisor in respect of the premises licence or at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence

If this premises licence authorises the exhibition of films:-

1. Admission of children must be restricted in accordance with any recommendation made by the British Board of Film Classification.

If this premises licence details the use of door supervisors

1. All persons employed as door supervisors must be licensed by the Security Industry Authority.

Additional Conditions

The maximum number of persons permitted to be on the premises shall be:

Ground Floor 100

First Floor 70

Second Floor 30

All persons involved in door supervision activities at the premises (as defined in the Private Security Act 2001 Schedule 2) must hold a licence issued by the Security Industry Authority.

Door Supervisors should note and record all incidents in a Daily Log Book. That book shall be available for inspection by any Police Officer or representative from the Borough Council.
