2	There should be absolutely NO CHANGE to the current discount available under Class A and Class C exemptions Properties currently falling into Class C exemption are predominantly tenanted properties that become vacant in between tenancies. Landlords do not wish to have any void periods in between tenancies but will naturally occur. During void periods the landlord still has to pay the mortgage out of his own pocket. If he is forced to pay council tax too, then he may not be able to afford to do so, leading to the property being re-possessed by teh lender. Ultimately there will be one less property for private rental There is already a shortage of rental properties. Remember, it is the occupant of a property that derives benefit and thus should be liable to pay council tax.
