Annex 1 Mandatory conditions

If this premises licence authorises the sale by retail or supply of alcohol to members or guests:-

- 1. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relations to the premises.
- 2. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to
 - i. drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol) or
 - drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
 - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

the outcome of a race, competition or other event or process, or the likelihood of anything occurring or not occurring:

- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 3. The responsible person shall ensure no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 4. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

- 5. No supply of alcohol may be made under the premises licence at times when there is no designated premises supervisor in respect of the premises licence or at a time when the designated premises supervisor does not hold a personal licence or his/her personal licence is suspended.
- 6. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence
- 7. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- 8. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 9. The responsible person shall ensure that
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - i. beer or cider: 1/2 pint
 - ii. gin, rum, vodka or whisky:25ml or 35ml; and
 - iii. still wine in a glass:125ml; and
 - (b) customers are made aware of the availability of these measures.

If this premises licence authorises the exhibition of films:-

10. Admission of children must be restricted in accordance with any recommendation made by the British Board of Film Classification.

If this premises licence details the use of door supervisors:-

11. All persons employed as door supervisors must be licensed by the Security Industry Authority.

Annex 2 – Conditions consistent with the operating schedule

Embedded Conditions Apply (The licence is granted on the condition that the restrictions contained within the enactments specified under Licensing Act 2003 Schedule 8 (6) are adhered to).

We will obtain and maintain membership of an appropriate Pubwatch if there is one or if one becomes available

We will involve our premises in appropriate local police/council initiatives if or when necessary to promote the prevention of crime or disorder

We will ensure staff training is provided where appropriate to include drug awareness. The licensing act etc

We will obtain and maintain membership of an appropriate Pubwatch if there is one or if one becomes available

We will involve our premises in appropriate local police/council initiatives if or when necessary to promote the prevention of crime or disorder

We will ensure staff training is provided where appropriate to include drug awareness. The licensing act etc.

We will ensure staff training is provided for Health and Safety where appropriate We will ensure one member of our team will be first aid trained

We will regularly carry out risk assessments and ensure staff instruction is given We will undertake no irresponsible drink promotions.

Children must be accompanied by an appropriate adult

Appropriate adults will be reminded that children are their responsibility and that the external area is unsupervised.

We will have doors and windows closed when live music is playing

Period of chill-out will be allowed after live entertainment

We will request customers leave our premises in a quiet and orderly fashion. We will ensure our external garden areas close at an appropriate time with regards to our neighbours.

All external doors, other that those used for emergency exits only, shall be fitted with automatic closing devices. The doors shall be kept closed, so far as is practicable, at any time when regulated entertainment is taking place, or facilities are being provided for regulated entertainment.

All external windows shall be kept closed at any time when regulated entertainment is taking place, or facilities are being provided for regulated entertainment.

Ventilation shall only be provided by suitable and sufficient mechanical means (the amount of ventilation provided is also a requirement under Health and safety legislation). The mechanical system shall be operated as required and maintained thereafter.

All Emergency exit shall be fitted with well sealed acoustic doors.

The handling of beer keys, bottles and other similar items external to the fabric of the building, in particular the emptying of glass bottles into refuse containers, recycling bins or returns crates and the stacking of such crates shall only be permitted between the hours of 09:30 and 21:30 hours daily.

The Licensee(s) must at all times ensure, as far as is practicable, that people on, or leaving, the licensed premises conduct themselves in an orderly manners, and do not cause annoyance to the neighbourhood.

External laser effect lighting, and pyrotechnic firework displays shall not be permitted without the prior consent of the Licensing Authority.

No regulated entertainment, or the provision of facilities for making music or dancing shall be permitted to be held if it causes an unreasonable disturbance to the occupiers of any other premises.

Regulated entertainment, in the form of the performance of live music, the playing of recorded music, the provision of facilities for making music, and the provision of facilities for dancing shall only take place indoors between the hours of 11:00 hours and 23:30 hours Sunday to Thursday, and 11:00 hours and 00:30 hours Friday and Saturday. The standard hours shall be extended to allow the performance of live music, the playing of recorded music, the provision of facilities for making music, and the provision of facilities for dancing from 11:00 hours on 31st December until 23:00 hours on 1st January, and at no other times or locations.

The external drinking areas shall not be used for the purposes of any regulated entertainment and shall be cleared of patrons by 23:00 hrs daily, and access shall be prohibited for the purposes of the consumption of alcohol after this time.

Nothing contained in these conditions shall prejudice or affect the operation of any relevant statutory provision and accordingly if any requirement of these conditions is inconsistent with any statutory requirement the statutory requirement shall prevail.
