Northamptonshire Police operate a RAG Matrix (Red/Amber Green) whereby incidents at licensed premises are graded according to their severity; incidents which are scored must be in or directly linked to an individual premise. Bar Q'Bano was shown in 'RED' in March 2009. A meeting was held with owner, and as a result CCTV system upgraded and advice given in respect of reducing issues of drunkenness and violence. At that time it was felt that the owner, Pravin SADRANI was too 'hands off' and failing to address problems at the premises, it appeared that nothing had changed in that respect. Drunken violence continued.

17th June 2010 Northamptonshire Police called for a review of the premise license, that was subsequently heard on 03rd Aug 2010. (Details of that review application are attached to this one)

Licensing Panel determination on 03 Aug 10 was:

- Incident book / refusals register to be kept
- Door supervisors in place Thu Sat from 2100hrs
- Training for managers (documented)
- Always at least one personal licence on site when alcohol sold
- 'Add on' of installing 5 extra CCTV cameras

Initially an improvement was seen however several incidents throughout early 2011 lead to premises showing 'AMBER'.

July 2011 The police licensing officer – PC Murphy met with SADRANI and advised that improvement was required especially in respect of door-staff who appear to be failing in their duties

09 Sep 11 PC Murphy and PS Fletcher (then a licensing Sergeant) met with SADRANI and his legal rep Colin Hobbs at the premises to discuss an application to vary the Premises Licence. An application subsequently submitted for additional hour of licensable activity and slight amendments to condition wording. These were agreed on the back of verbal assurances around more 'hands on' running of the premises by SADRANI.

Oct 2011 PC 949 WOOLMER was flagged down by doorstaff and upon arrival doorman stated that he had been punched by a female and that they were throwing her out of the pub. Doorman did not wish to pursue complaint and asked for female to be taken off the town centre. Sec 27 served. Staff were reported to be very good/helpful.

Nov 2011 NP/38041/11. Person enters toilets and is seen snorting white powder. Staff call police and a small bag of powder recovered from offender - offender received a caution.

Dec 2011 PC 934 GRAY visited premises to check with doorstaff on numbers within. First doorman was asked how many persons inside he replied 'loads'. Second doorman said that none of them had clickers and that there were about 60 inside. Officer went in to check and there were about 120.

The following reported crimes are connected with the bar:

21 Apr 12 1900hrs NP 3643/12

ABH assault – known person approaches i/p in bar and punches to left side of face – note on crime that owner failing to provide CCTV

20 May 12 0030hrs NP 8159/12

Common assault on male member of bar staff – offender gets behind bar and pulls i/p by t shirt causing him to fall – t shirt is ripped, glasses fall off and are damaged and reports soreness to neck

15th Sep 2030hrs which was reported as a fight inside – no complaints – S27 (Direction to leave area) to one male.

15 Dec 12 0300hrs NP 43746/12

ABH assault – known female throws glass at victim which strikes him in the face causing a 1cm cut to right cheek

03 Feb 13 0130hrs NP 51655/12

ABH assault – Male offender head-butts i/p to the face causing swollen lips and two chipped teeth.

10 Feb 0200hrs 13 NP 53234/12 cross ref NP 53243/12

ABH assault – female offender grabs female i/p around throat and throws to floor causing minor bruising to neck

10 Feb 0200hrs 13 NP 53243/12 cross ref NP 53234/12

Common assault – female offender grabs female i/p by ponytail and pulls head backwards

22 Feb 13 2230hrs NP 56152/12

GBH assault – unknown male in an unprovoked attack punches male i/p repeatedly to the head causing fractured jaw and damaged eye socket

17 Mar 13 0055hrs NP 58290/12

ABH assault – I/P is member of door-staff who during the course of his duties is assaulted by a male who punches him to the face causing reddening and swelling under left eye.

In October 2012 intelligence was received by the police in relation to the supply of controlled drugs and criminal activity within the premises. This intelligence was of sufficient quality to warrant a covert operation. Undercover officers were deployed into the premises to observe the activity therein over a period of 4 months. This culminated in the execution of a search warrant at the premises on 14th March 2013. The results of the covert operation and that warrant corroborated the intelligence and has resulted in a criminal investigation against Nicolino PROVENZANO who was managing the premises throughout that period.

Provenzano is currently on delay charged bail for a number of offences and the case is still ongoing and subject to sub-judice therefore Northamptonshire Police make application to the sub-committee that the details of this investigation are heard exparte and in private in accordance with regulation 14 (2) & (3) of the Licensing Act 2003 (Hearings) Regulations 2005. It is in the Public interest that the members of the sub-committee are made aware of the nature of the Police investigation without jeopardising any criminal prosecution.

Details of the supportive evidence for this aspect of the hearing are at Annex 'A' and are not for public disclosure

When the warrant was executed a number of exhibits were seized, these include:

- £710 in suspected counterfeit currency (£20, £10 & £5 notes)
- A quantity of suspected controlled drugs (Class A),
- A number of bottles of wine, and spirits suspected to be either counterfeit or illegally imported
- A number of packets of tobacco/cigarettes suspected to be either counterfeit or illegally imported

Northamptonshire Police are requesting that the licensing committee consider revocation of the license. We can demonstrate that the premises and its management is associated with persistent criminal activity, which has been occurring over a number of months. In addition there have been a number of assaults of varying degrees of seriousness over the last 12 months also indicating there is little control over the safety of patrons.

The Police have tried to impress upon the Premises License holder, Pravin SADRANI, the importance of him having greater control over the management and activities at the premises which, by and large, he has ignored as evidenced above
