4. This Notice will take effect at the end of the period of two months after the service thereof upon you.

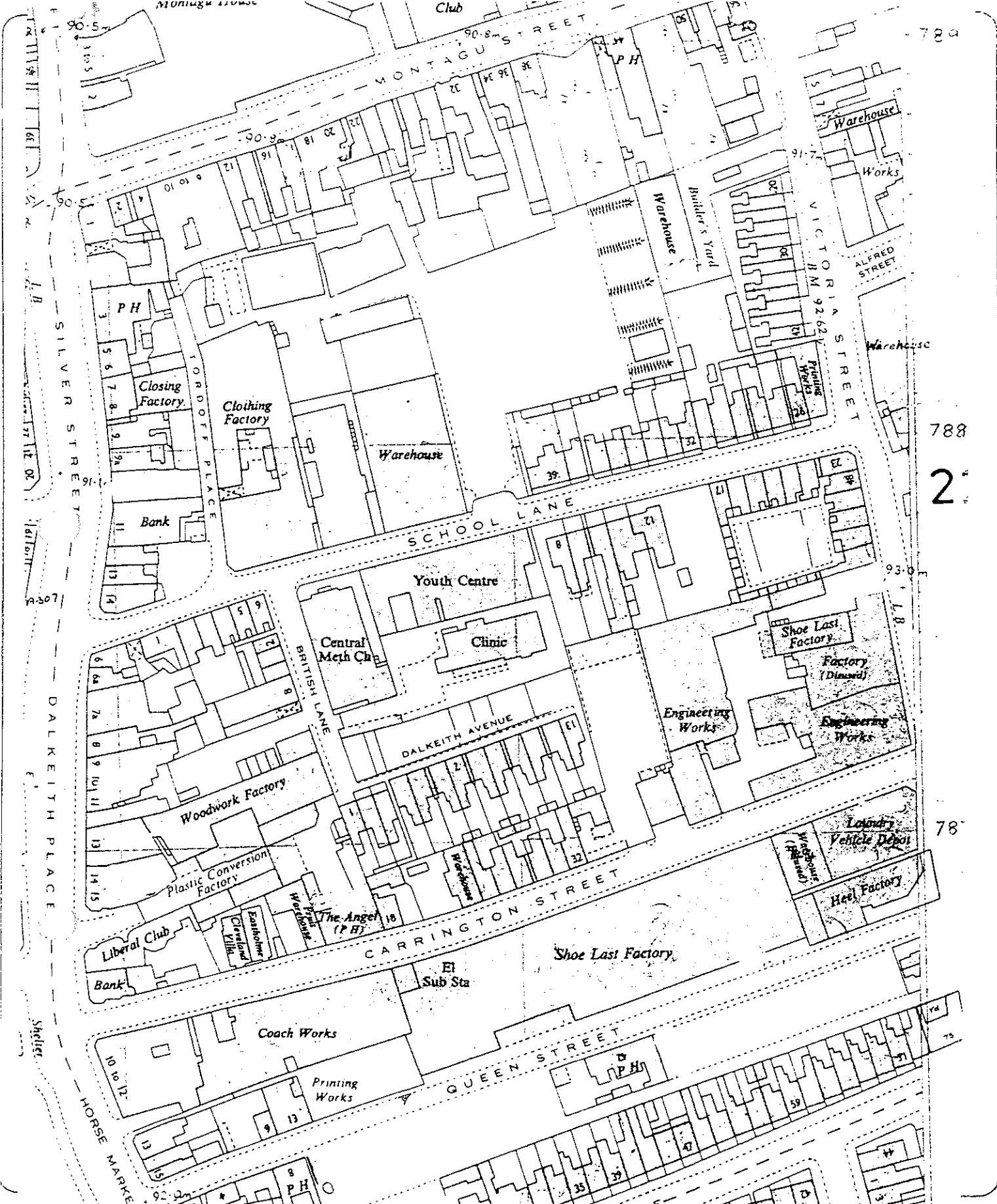
